ELIGIBILITY

The nominee must be a female junior or senior high school student during the 2019-2020 school year. It is open to anyone who identifies as female. She may not be a previous YWCA Tribute Award recipient. Self-nominations are not accepted.

3. Describe the **POSITIVE IMPACT** the nominee's actions/activities have had on her life and/or on the lives of others.

4. REFLECTION OF YWCA VALUES

NOMINEE PROFILE GUIDELINES

- In narrative form, please address all six Nominee Profile areas individually, with each section titled.
- The complete nominee profile may not be more than two one-sided pages, printed or typed, in addition to the nominee/nominator information on the back of this page.
- Title each section of the profile so that each can be scored separately by the Selection Committee. All sections of the profile will be weighted equally during the scoring process.
- Your nomination will be the only item the Selection Committee will consider in its decision-making process. Do not submit any other documents, as they will not be shared with the Selection Committee.
- You may want to consult with others, even your nominee, to be sure you are including all of her activities and accomplishments.
